Sir

The matter regarding renewal of annual recognition to Tennis Ball Cricket Federation of India (TBCFI) has been examined. The last election of office bearers of the federation held on 16.02.2020 for the term 2020-2024 was taken on record by the Ministry.

2. The matter has been considered in the Ministry and it has been decided to renew recognition of Tennis Ball Cricket Federation of India for one year with effect from date of issue of this letter.
3. It has been noticed that constitution / Article of Association of the Tennis Ball Cricket Federation of India needs to be aligned with the provisions of the National Sports Development Code of India, 2011 (Sports Code). Accordingly, TBCFI is required to make categorical affirmation of the provisions of Sports Code in its constitution within 6 months so as to bring the same fully in line with the provisions of the Sports Code. The Federation is also required to take necessary steps for uploading of the information in compliance to the instructions as contained in this Ministry's letter no. 9-7/2014-SP.I dated 26.02.2015 (copy enclosed) on suo-moto disclosure within 3 months' time.

Sub:- Inclusion of sports disciplines in the list of games for recruitment of meritorious sports persons to any post in Group 'C' in Ministries/Department of Government of India – regarding.

The undersigned is directed to refer to this Department's OM of even number dated 01.09.2020 and to say that a proposal has been received from Department of Sports for inclusion of one more discipline in the list of sports disciplines for recruitment of sportsperson to any Group 'C' post in Ministries/Departments of Government of India.

2. It has now been decided to accept the recommendation of Department of Sports. Accordingly, in partial modification of this Department's OM of even number dated 01.09.2020, one more discipline namely **"Tennis Ball Cricket"** is added at Sr. No. 64 in the list of sports disciplines for recruitment of sportsperson to any Group 'C' post in Ministries/Departments of Government of India.
